IRBM TO STOP ACCEPTING TAX PAYMENTS BY CHEQUES DELIVERED VIA MAIL OR COURIER SERVICES STARTING 1 JANUARY 2021

1. In line with the government's effort to increase the usage of online payment (e-payment), the Inland Revenue Board of Malaysia (IRBM) wishes to inform that tax payments by cheques delivered via mail or courier services will no longer be accepted starting 1 January 2021.
2. This move, however does not apply for the following payments: -
 - 2.1 Real Property Gains Tax (RPGT);
- Tax under Section 21B of the RPGT Act 1976 (Form CKHT502)
 - 2.2 Public Entertainer's Income Tax (*Seniman Kembara*);
 - 2.3 Withholding Tax; and
 - 2.4 Compound
3. Alternatively, tax payments can be made via the following methods starting 1 January 2021:-

- 3.1 ByrHASIL portal at www.hasil.gov.my;
 - 3.2 Internet banking facilities of commercial banks which have been appointed as tax collection agents by IRBM;
 - 3.3 Payment counters at IRBM's Payment Centers;
 - 3.4 Over the counter of banks appointed as collection agents;
 - 3.5 Cash / cheque deposit machine; and
 - 3.6 Automated teller machine (ATM).
4. For payment made over the counter at any appointed banks, taxpayers are required to provide the following information:-
- 4.1 Income tax file reference number;
 - 4.2 Full name and MyKad number;
 - 4.3 Year of assessment and number of tax installments paid;
 - 4.4 Tax payment code; and
 - 4.5 Amount of tax payment.
5. Please note that no receipts would be issued by the IRBM for e-payments or payments made at appointed banks, instead taxpayers or their representatives must keep the payment slips for each transaction made.

6. Taxpayers or tax representatives are advised to ensure compliance with the new ruling and ensure any tax payments using posted cheques must be received before 1 January 2021 failing which late payment penalty will be imposed.
